Liability Release

2. Acknowledge and fully understand that registered minors will be engaging in activities that involve risk of injury which might result not only from their own actions, inactions or negligence, but the action, inaction, or negligence of others, the rules of play, or the conditions of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
3. Assume all the foregoing risk and accept personal responsibility for the damages following such injury.
4. Release, waive, discharge and covenant not to sue St. Joseph Parish, St. Joseph Athletic Association and St. Joseph Football Program(CFA League Member) and the respective officers, agents, coaches, servants and other employees of the organizations, and if applicable, owners and lessors of premises used to conduct the event, all of whom are hereinafter referred to as “releasees”, from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, caused or alleged to be caused in whole or in part by negligence of the releasees or otherwise.
